CONSTRUCTION UPDATE

Work remaining includes but not limited to ♦ Completion of fill and stone placement at north end of island ♦ Install dockage in the maritime basin ♦ Install fishing pier in quiet water basin ♦ Install railings at top of sheet pile caps ♦ Complete landscaping ♦ Complete installation of concrete lakewalk at bridge and along lakeside of island ♦ Bridge painting, railing and lighting installation ♦ Install lighting along lakewalk ♦ Completion of roadway, stone placement, and lighting on outer breakwater.

Work has continued as weather conditions allow for concrete and electrical work. The construction activity should resume in full intensity by mid-March to reach completion of the entire project by June 1, 2007.

AT THE PARK

Lakeshore State Park will offer boat docks, a lakeside multi-use trail and improved fishing access. Additionally, the park will connect the Hank Aaron State Trail, the Oak Leaf Trail and Milwaukee's recreational lakefront resources as part of a path from Lake Michigan's shore to the banks of the Mississippi River. A park visitor center with boat slips, public restrooms and showers for overnight boaters is planned for the future.

Educational programs related to the park will explore the cultural history of the lake, focusing on fishery and its importance to this area. Opportunities abound to team up with many partners to offer programs on the natural history of Lake Michigan and Milwaukee's river systems.
